Information

Section 1902(a)(13)(C) of the Social Security Act specifies that physicians with a primary specialty designation of family medicine, general internal medicine, or pediatric medicine are primary care providers for purposes of increased payment for evaluation and management services and services related to immunization administration for vaccines and toxoids for specified codes would be eligible for reimbursement. In order to be eligible for the increased payment the following requirements must be met:

- The provider must be a physician defined in 42 CFR 440.50, or under the personal supervision of a physician who accepts professional responsibility and self attests to a specialty designation of family practice, general internal medicine, or pediatric medicine or a subspecialty recognized by the American Board of Medical Specialties (ABMS), American Board of Physician Specialties (ABPS), or the American Osteopathic Association (AOA); or,
- Have furnished evaluation and management (E&M) and vaccine services that equal at least 60% of the Medicaid codes billed during the most recently completed calendar year.

Certification and Attestation

I attest that I am a qualifying physician with a specialty or subspecialty certification recognized by the ABMS, ABPS, or the AOA; or, that 60% of my total billing meets the requirements to receive the increased payment for primary care services provided by myself, or under my direct supervision, in compliance with federal and state regulation for the period specified above. - I hold board certification in family medicine, general internal medicine, or pediatric medicine;*
- I hold board certification in a qualifying subspecialty recognized by the ABMS, the ABPS, or the AOA;*
- 60% of all services billed to Medicaid during the most recently completed calendar year are for the evaluation and management and vaccine administration codes specified in federal regulation (currently enrolled providers only); OR,*
- 60% of all services billed to Medicaid during the most recently completed calendar month are for the specified evaluation and management and vaccine administration codes (newly enrolled providers only).*
