Our records indicate that one or more Prestige Health Choice members may have recently filled a prescription for Ranitidine that originated from your office. On April 1, the U.S. Food and Drug Administration (FDA) announced it is requesting manufacturers withdraw all prescription and over-the-counter (OTC) Ranitidine drugs from the market immediately.
